1. Dignity4Patients is committed to guarding the privacy of users of our website. We are aware that as a user of this website you may be cautious about the security and privacy of your information.

2. As you use this website information can be received by us. This information may be used to enable us to improve the website and to enable us to respond to your requests.

Our website does not use cookies apart from temporary 'session' cookies which enable a user's web browser to remember which page on the website it has already visited. Users can use our website with no loss of functionality if cookies are disabled from the web browser.

Technical details in connection with visits to the website are logged by our internet service provider for statistical purposes. No information is collected that could be used to identify our website visitors. The technical details logged are confined to the following items:

The IP address of your web server used to access our site.

The domain name used to find us (e.g. .ie, .com, .org)

The previous web address from which you reached us, including any search criteria used.

Click screen data which shows the pages accessed on our website.

The type of web browser used by you to visit our website.

This information is used in a cumulative form to generate statistics and usage of the website and to improve the usefulness of the website. Dignity4Patients will make no attempt to identify individual visitors or to associate any technical details listed above with any individual.

3. In order to make a donation to Dignity4Patients through PayPal or to register with us as a volunteer you will be asked for information. We will require amongst other things your name, email address and telephone number. Personal data is collected only with your knowledge and permission and is retained by Dignity4Patients in a secure manner.

4. In addition, when you make a donation on the website we will also require your credit/debit card details. The information received from you will only be disclosed to such third parties as may be necessary, in order to process your donation. When making a donation, you will be transferred to a secure encrypted Dignity4Patients page hosted by our credit card and debit card processor Paypal, who will perform the transaction on our behalf from your credit card or debit card. Your card details will not be divulged to Dignity 4 Patients.

5. We will take reasonable precautions to prevent the loss, misuse or alteration of information you give us.
